Use your Meal Entertainment funds for meals consumed with others at restaurants, cafes, pubs, clubs and bistros.



Meal Entertainment funds cannot be used for onsite workplace meals or drinks; alcohol (unless consumed while dining out with others); general entertainment (such as movie or theatre tickets); and groceries.
